**TERMS OF AGREEMENT**

- Failure to complete booking and payment prior to a swimmer's entry in the water may result in a swimmer not being permitted to enter the pool or possible removal from a class.
- Squad fees are to be paid monthly before a child is allowed to swim. Learn to Swim fees are paid by term.
- Squad swimmers will be booked automatically each month. Please give two weeks' notice to terminate their lessons.
- Fees can be paid by cash, cheque, credit card, or EFTPOS.
- Class and Squad fees can be pro-rata at point of entry into a program only.
- Non-attendance does not qualify for a refund or credit except under special circumstances, where a written application must be made via the Aquatics Administrator.
- Requests for medically related credits or make-ups must be submitted in writing. In order to be considered, supporting medical documentation must be supplied at the time of submission.
- Make-up lessons for Learn to Swim cannot be guaranteed and will only be accommodated when a minimum 24 hours' notice of an absence has been given.
- Make-up lessons are conditional upon a suitable vacancy being available. All make-up lessons must be taken in the current term. Once a make-up lesson is booked in, it cannot be rescheduled. If a swimmer fails to turn up, then the make-up is forfeited. There are no make-up lessons for public holidays or scheduled pool closures, as fees are already pro-rata to account for pool closures.
- Lessons will not be cancelled due to weather unless a safety situation is declared by the Coaching Director. Make-up lessons will not be offered due to weather conditions.
- If a coach is unavailable, we reserve the right to use a substitute coach for the lesson.
- Program change requests made after initial enrolment will be carried out based on availability of space and cannot be guaranteed.
- Parents/Guardians are responsible for the timely drop off, pick up, and pool deck supervision of their swimmers outside planned lesson times. No child is ever to be unsupervised on School grounds.
- In joining the program, I give St Hilda's School consent to take photos/videos of my child and use these images/footage to promote St Hilda's School swimming or in any St Hilda's School marketing activities.
- The St Hilda's Aquatic Centre has the St Hilda's Aquatics Swimming Club, which is affiliated with the Queensland Swimming Association (QSA). It is an expectation of those squad members who wish to compete in meets run by this association to compete as a member of the St Hilda's Aquatics Swimming Club only.
